

## GENERAL TERMS AND CONDITIONS CENTREON CLOUD TRIAL

By participating in the Centreon Cloud Trial, you agree to these general terms and conditions and to the general terms and conditions of use of the product available at the following link: <https://www.centreon.com/legal/en/Cloud-Services-terms-ROW> as well as to the CIAM general terms and conditions of use: <https://www.centreon.com/legal/en/centreon-ciam-services> and confirm that you meet all the eligibility conditions described below. Submission of the application form in no way constitutes a guarantee of access to the trial offer.

### 1. CONDITIONS ELIGIBILITY

The trial offer is exclusively reserved for legal entities. Only one trial offer per 3-month period is authorised per legal entity via employees and/or managers evaluating the purchase of IT products and services on their behalf.

The trial offer is strictly reserved for end users for professional evaluation of its functionalities. This trial cannot under any circumstances be considered as a demonstration licence. As such, partners, resellers and distributors are not eligible for this trial and cannot benefit from it as part of their commercial or promotional activities.

### 2. SCOPE OF THE OFFER

The trial offer concerns exclusively the Centreon Cloud IT Edition product. No other product or service offered by Centreon is included in this offer.

Access to Centreon Cloud Trial is subject to product availability.

For the duration of the trial, the user benefits from access to the functionalities of the Centreon Cloud IT Edition product, as they are available in the standard commercial offer. However, Centreon reserves the right to limit the functionalities of the product within the framework of the Centreon Cloud Trial, either for security reasons, or for reasons of optimisation of hosting infrastructures.

Centreon reserves the right to modify or cancel the program at any time without notice.

The offer program does not constitute a POC (Proof of Concept). For all POC requests, please contact the Centreon sales department.

### 3. DURATION OF THE OFFER

The duration of the offer is strictly limited to seven (7) calendar days, as of the submission of the request carried out by the user on the Internet site of Centreon [www.centreon.com](http://www.centreon.com). No renewal or extension will be granted unless expressly agreed by Centreon.

Any subscription request must be initiated by the user with the sales department and will result in the provisioning of a new Centreon Cloud production instance.

### 4. EXPIRY OF THE OFFER

At the end of the trial period, access to the platform will be automatically deactivated and all associated data permanently deleted, with no possibility of recovery.

It is up to the user to take all the necessary measures before the end of the offer, in particular by uninstalling the specific components which it would have added to its infrastructure, such as the pollers, agents, extensions or any other third module. Centreon cannot be held responsible for any persistence of configuration or possible disturbances resulting from the absence of uninstallation by the user.

### 8. EXPORT CONTROLS
